This includes, but may not be limited to, providing an acceptable Individual Performance Plan (IPP), attendance at a pre-event camp and wearing team uniform as required and make themselves available for all team activities designated by Swimming NZ. 5.3 not act in such a manner as to bring themselves or Swimming NZ into public disrepute. 5.4 be available compete in relay events that, in the opinion of the Swimming NZ team management, do not interfere with individual races.



6. Performance Requirements

6.1 To be considered for selection for an individual event in the 2022 Mare Nostrum series, athletes must record a time equal to or better than the times detailed in Table 1 in the relevant Individual Swimming Event at any FINA approved Long Course event subject to Clause 8 below.

6.2 Selection to the Team:

- 6.2.1 At the conclusion of the Selection Events, each eligible athlete who achieves a qualifying time as per Table 1 at a selection event and complies with all Eligibility Rules outlined in section 4 will be considered for selection.
- 6.2.2 The maximum team size is 30.
- 6.2.3 Should more than 30 athletes achieve the performance standard, the following ranking system shall apply:

Athletes achieving:

- a. FINA A in an Olympic event
- b. FINA A in a non-Olympic event
- c. FINA A +1% in an Olympic event and are male age 21 or younger on 31^{st} Dec 2022, or female 20 or younger on 31^{st} December 2022.
- d. FINA A +1% in a non-Olympic event and are male age 21 or younger on 31st Dec 2022, or female age 20 or younger on 31st December 2022.
- e. FINA B in an Olympic event
- f. FINA B in a non-Olympic event

	6.2.4 Should there still be a tie after athletes have been ranked as per 6.2.3, the athletes with the time closest to the FINA A time in the relevant individual event will be selected.
7. Team Announcements	7.1 The selection of the athletes that have met the eligibility and performance requirements will be announced no later than Tuesday 26 th April 2022.
8. Extenuating Circumstances	8.1 Extenuating Circumstances 8.2 If an athlete is unable to compete at the Selection Events due to extenuating circumstances (as set out below), the Swimming NZ Selectors may consider previous performances within the 12 months prior to the Selection Events in a long course event at a competition acceptable to the Swimming NZ Selectors.
	8.3 Athletes must advise the Swimming NZ Selectors (via the HP Manager amanda@swimming.org.nz) of the extenuating circumstances and reasons, in writing, prior to commencing the individual event. If Swimming NZ is not notified of any extenuating circumstances before the athlete commences their individual race, then the Swimming NZ Selectors have no obligation to rely on such circumstances.
	8.4 In considering the selection of athletes in accordance with the selection criteria, the Swimming NZ Selectors may, in their sole discretion, give weight to any extenuating circumstances which may include, but are not limited to, the following:
	 Injury or illness Travel delays Equipment failure Bereavement or personal misfortune Covid-19 (pool closures) Any other factors reasonably considered by the Swimming NZ Selectors to constitute extenuating circumstances.
	8.5 In the event of illness or injury, athletes will be required by the SNZ Selectors to provide a medical certificate and may be required to undergo an examination by a health practitioner/s nominated by Swimming NZ, and to provide that opinion and/or report to the Swimming NZ Selectors including an indication of the current and future performance impact of the condition. Any failure to agree to such a request may result in the Swimming NZ Selectors being unable to consider the injury or illness as an extenuating circumstance.
	8.6 Selection of any athletes, as outlined above, will be subject to confirmation of their satisfactory return to training. This process is to include a test in the swimming event that they have been selected for. The test must be performed by a designated date decided by the Swimming NZ Targeted Program Manager. A target time indicating satisfactory progress will be decided and announced to the athlete before the designated date
